- ¹ The credit rate for a particular school or average Tuition Level is subject to change in the event that the school, or a school included in the average, changes its tuition rate for academic year 2015-2016. Some of the credit rates reflect the assessment of a premium designed to maintain the fiscal integrity of the Guaranteed Savings Plan. (See footnote 3.)
- ² Millersville University (PA Resident Rate), California University (Active Military & Family Rate), the PA College of Technology, and some community colleges (as indicated on this PA 529 GSP Credit Rate Schedule) charge only by the academic credit, not by the semester. Therefore, semester rates are not listed for those schools. For schools that charge a semester rate, the PA 529 GSP Semester Rate is the sum of either 12 or 15 PA 529 GSP Credits, depending on the actual rate set by the school. (See footnote 17.)
- ³ The following credit rates include premiums: State-Related University Average (5%), Pennsylvania State University - all Tuition Levels (5%), and University of Pittsburgh - all Tuition Levels (5%).

⁴ In calculating the State-Related University Average, all State-Related University Tuition Levels that were used in calculating the average for academic year 2004-05 were used; any Tuition Levels that were added in academic year 2005-06 or after were not included.

⁵ In order to be eligible for this credit rate, certain conditions apply, as briefly described below. Please contact the school for more information.

All "Active Military & Family": All active duty military (Army, Navy, Air Force, Marine Corps, Coast Guard, National Guard, and Reserves) and dependents and spouses of active duty members enrolled in the Global Online Program (California, Mansfield, and Slippery Rock).

East Stroudsburg 1: High-achieving domestic out-of-state students. Minimum credit loads required.

East Stroudsburg 2: High-achieving transferring students and certain international students with qualifying GPAs. Minimum credit loads required.

Edinboro: All newly-enrolled domestic out-of-state students.

Indiana: Freshmen and transfer students from specified states; high-achieving Freshmen and transfer students; and international students with established academic agreements.

Kutztown: High-achieving domestic out-of-state students.

Kutztown A: High-achieving transfer and domestic out-of-state students.

Lock Haven: High-achieving domestic out-of-state students.

Mansfield: Students from New York and New Jersey.

Millersville: Domestic out-of-state students entering with a STEM major and high-achieving transfer students.

Millersville A: Domestic out-of-state high-achieving students.

Shippensburg: Transfer students from specified Maryland community colleges.

Shippensburg A: High-achieving students or students with a STEM major.

Slippery Rock: High-achieving Freshmen, transferring, and returning students.

Lehigh-Carbon: Schuylkill County residents.

Northampton County: Residents of Monroe County School District.

⁶ The rates for this Tuition Level are based on the average of Freshman, Sophomore, Junior, and Senior tuition charges for all programs of study except those for which separate Tuition Levels are specified. Starting in academic year 2016-17, for beneficiaries at this Tuition Level, all payments from the GSP at this Tuition Level will be made at the Average Actual Tuition of the class levels used in calculating the rates (Average) regardless of the academic status of the beneficiary. For academic years 2013-14 until 2016-17, payment will be made at the Average Tuition rate or the Actual Tuition set by the school for the class level which the beneficiary has attained (Actual) as indicated in the following chart:
